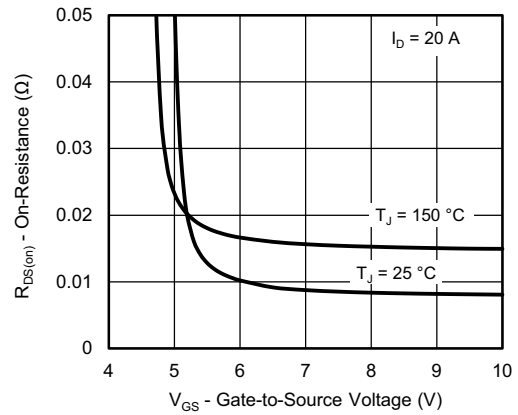

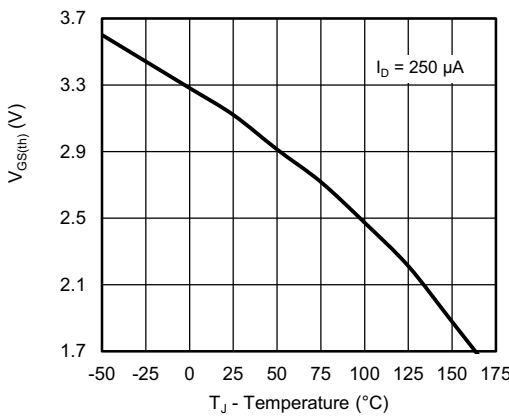

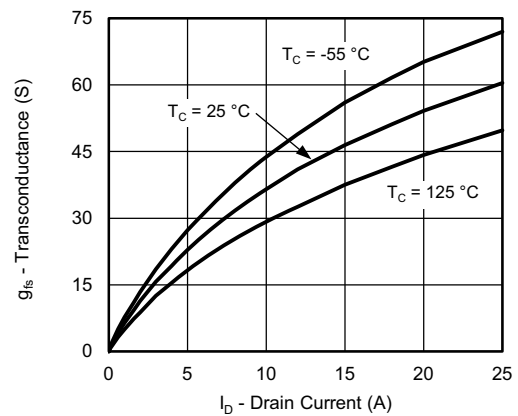
**Source-Drain Diode Forward Voltage**



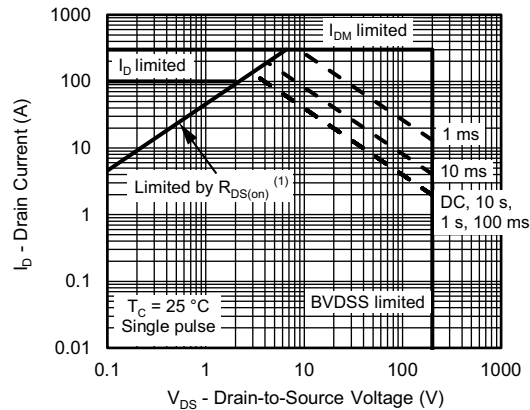
**On-Resistance vs. Gate-to-Source Voltage**

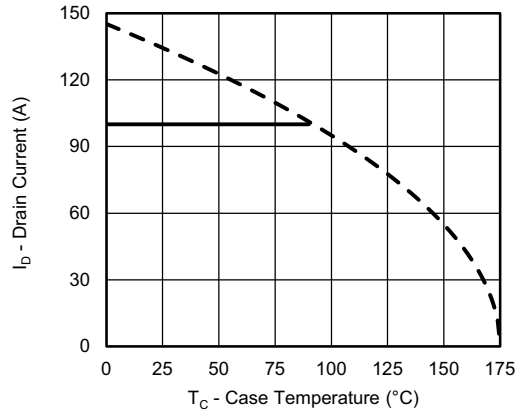

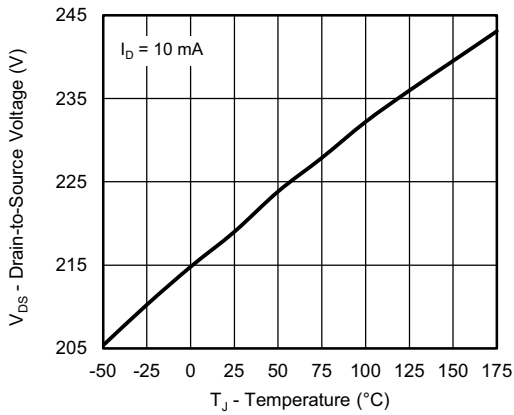

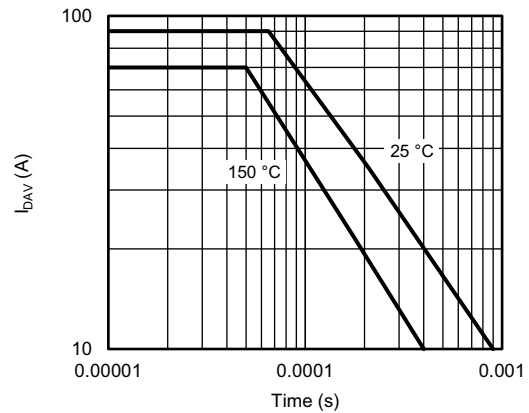

Drain Source Breakdown vs. Junction Temperature



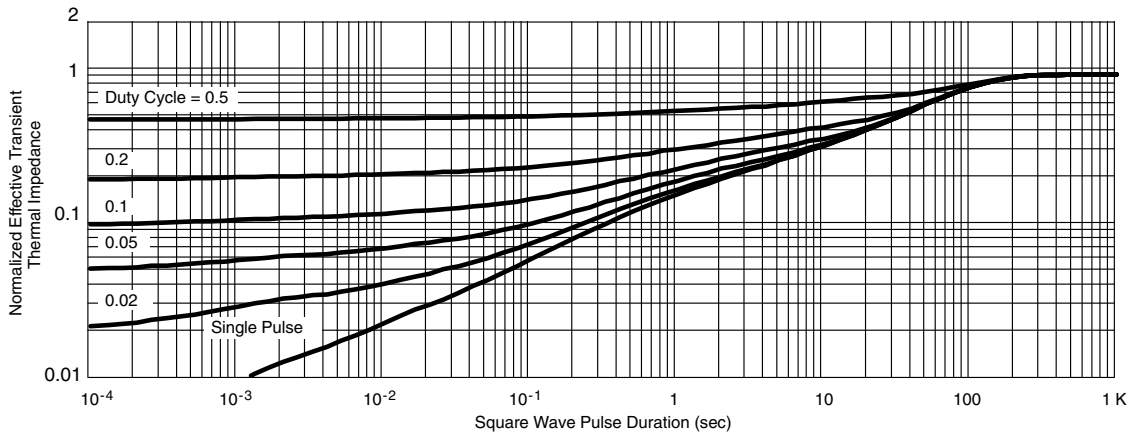
$I_{DAV}$  vs. Time

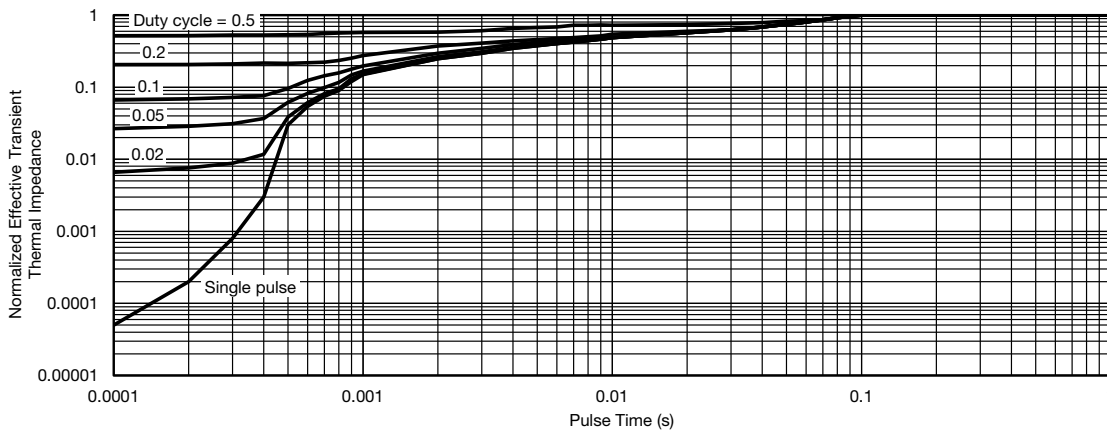
